## **TWO-YEAR HEALTH GUARANTEE**

On the date of purchase, I was instructed to take my puppy to a licensed veterinarian within two business days time for a health & wellness checkup. If the vet finds the puppy has a life-threatening health problem, I am then entitled to a full refund or an equal value puppy, with proof from vet. If the puppy is not taken to the vet within two business days, then I forfeit all rights of return and/or refund under any provisions of the two-year health guarantee. Veterinarian health & wellness checkup activates this puppy's two-year health guarantee, from the date of purchase, against any life-threatening illnesses. If such illness is discovered, I am entitled to a refund or exchange for an equal value puppy, at the discretion of the breeder, upon return of the original puppy to the breeder at the address above. Other than these two, specific, limited guarantees, I understand that I am responsible for any future vet bills and for the mortality of my puppy.

*I agree that this puppy is being sold without any guarantee as to suitability for any specific purpose, and without guarantee as to ultimate size or color. I also agree never to breed this dog to any other breed, including, but not limited to: Labrador Retrievers, Golden Retrievers, etc. The penalty for such irresponsible breeding will be immediate forfeiture of the dog and any future rights to the dog and its offspring.*

If for any reason, the buyer finds it impossible to keep this puppy, at anytime during the puppy's lifetime, the buyer agrees to return the puppy to SeaBreeze Poodles in Tennessee. Transportation of the puppy back to Tennessee is buyers responsibility.
